### Spectrum Activities →Nov 2010

- PS spectrum efficiency report (PSCE-TA) published Feb 2010
- Analysys Mason PS BB report published March
- Both above reports delivered to EC DG INFSO April  $\rightarrow$  impact
- ECC/CEPT PPDR workshop Mar 11-12<sup>th</sup>: over 100 delegates, PCWP user input, needs recognised
- Lobbyist funded by TETRA A during early 2010
- 800 MHz Digital Dividend work lead to EC Decision (for mobile)
- PSC-E response to EC RSPP consultation delivered April
- ETSI SRDoc on BB PSS spectrum finally published Aug 2010
- . Redefinition of CEPT PPDR priorities (NB, WB) Sep 2010, LEWP input to those \*)
- 0. CEPT 400 MHz channel availability questionnaire by Nov 2010 \*)
- 1. German ministry funded studies on PPDR spectrum by Nov 2010 \*)
- 12. RSPP proposal to EP, about reasonable, industry lobby \*)

# Ongoing Activities/CEPT

Priorities by PT FM38 and WG FM in Sep 2010:

- 1. Additional harmonised 2 x 1.5 MHz for capacity extension < 430
- 2. New harmonised 2 x 3 MHz for data in 410 470
- 3. Continued BB studies
- And questionnaire started to clarify the band availability options
- Council LEWP (RCEG) input to ECC/CEPT Oct 2010
  - see next slide
- German MoEI (WIK) study report in ECC plenary Nov
  - see next slides
- FM38 questionnaire deadline was Nov 24
  - next FM38 is Dec 15/16 in Helsinki



## Law Enforcement WP

- Police Cooperation Working Party changed to LEWP in Lisbon Treaty
  - part of the EU Council organisation
  - chaired by the current EU Presidency (Belgium 2H2010, then Hungary)
  - I. LEWP
    - II. Radio Communication Experts Group (RCEG)
      - III. Forerunner Group
- RCEG input to ECC/CEPT Oct 2010 in response to latest CEPT priority list
  - 1. Put the 2 x 1.5 MHz extension in 380 400
  - 2. Put the 2 x 3 MHz data band in 410 430
  - 3. Find harmonised band for BB
- Document distributed widely to ECC Plenary, WG FM, PT FM38,
- Approval of the RCEG document at LEWP level in process since Nov 17th meeting COREPER December





### German PPDR study

- Mol study early 2010, MoE study late 2010
- German MoE has emphasised they want a harmonised European solution
- WIK presentation Oct for the ECC plenary
  - background data
  - need 1.9 Mbit/s uplink, like 2 x 15 MHz band if LTE like technology
  - impact assessment
  - opportunity cost
  - long list of proposals to German govt



## **Ongoing Activities/EU**

- Increased political traction was gained in EC during 2010
- RSPP proposal to EP and Council Sep 2010
  - Following the provisions of the Telecom Package
- Lobbying started by PSC-E to guide the RSPP
- Harmonisation proposal for BB PPDR by EC
  - see next slides
- High level EC workshop to follow, early 2011





### **RSPP** proposal

- Radio spectrum Policy Programme from the EC to EP and Council, every 2 years, this is the 1st
- Current proposal is out in EP for the first reading
  - 1. The need for BB PPDR spectrum below 1 GHz recognised as "shown by studies" to appear in 5 to 10 years
  - Proposal to ensure availability of spectrum < 1 GHz and equipment circulation "if necessary"
- EP ITRE and IMCO Committees, rapporteurs
- Lobbying effort to secure favourable outcome from both EP and Council
- PSC-E letter to ITRE rapporteur



## PPDR workshop proposal

- EC input paper to Radio Spectrum Committee on possible next harmonisation efforts (PMSE, PPDR, satellite)
- EC paper suggested even the next DD not to find a band for PPDR
- EC paper promoted the idea of sharing of government spectrum between PPDR and others like military
- Included proposal to arrange high level PPDR workshop between the EC and Member States, all stakeholders
  - supported by MS's in RSC Oct meeting
  - will happen
  - time and agenda yet unknown
